Facts:

On 03/30/1987, Lavern SCOTT AKA Cookie MONSTER AKA Lavern SCOTT AKA Cookie X was convicted of 1st Degree Sexual Assault, a class II felony in Douglas County, NE District Court.

On 10/12/1999, SCOTT was convicted of Attempted 1st Degree Sexual Assault, a class III felony, in Madison County, NE District Court.

Based on these convictions, SCOTT is required to register as a sex offender for LIFE in the State of Nebraska. NSORA requires a lifetime registrant to appear in person at the sheriff's office every three months to verify their information, based on their birth month. SCOTT's birth month is August, requiring him to appear every August, November, February and May for verification.

On 07/27/2004, SCOTT registered with the Nebraska Sex Offender Registry Unit as required by the NSORA.

On 10/09/2025, SCOTT appeared at the Douglas County Sheriff's Office (DCSO) and registered an address of 1117 N 17th Street, Omaha, Douglas County, NE 68102.

NSORA requires a lifetime registrant to appear in person at the sheriff's office every three months to verify their information, based on their birth month. SCOTT's birth month is August, requiring him to appear every August, November, February and May for verification. SCOTT failed to appear at the DCSO for verification in November 2025 and February 2026, in violation of the NSORA. The last time that SCOTT appeared at the DCSO for verification was 09/08/2025.
